

CLARK COUNTY CAMPGROUND RESERVATION

(Please read this carefully before completing the attached application)

With extended stays of 7 days or more, for every 6 days paid for at the normal rate - the 7th day will be at no cost.

RESERVATIONS ARE SUBJECT TO THE FOLLOWING:

1. Application must arrive or be postmarked at least 10 DAYS PRIOR to the first night of the reservation. Applications must be made on a Department Reservation Application form. Reservations are not valid unless accompanied by payment and confirmed in writing by the campgrounds or the Forest and Parks Department.
2. Reservations are made in person or by mail. Walk-in reservations must be made 5 days prior. TELEPHONE APPLICATIONS WILL NOT BE ACCEPTED.
3. A separate application must be submitted for each site desired. One person may submit applications for a maximum of two (2) sites. Each application must be accompanied by full payment for camping plus the \$5.00 reservation fee per site.
4. A camping party is any individual, family, individual group, juvenile group or unorganized juvenile group occupying a campsite.
 - Family - means a parent or parents with their unmarried dependent children.
 - Individual Group - means a camping party of not more than four persons occupying one camping unit.
 - Juvenile Group - means a group made up of juvenile members of an established organization and under the leadership of at least one competent, mature adult for each ten juveniles in the group.
 - Unorganized Juvenile Group - means a group made up of not more than three juveniles and accompanied by at least one adult. Such group is not affiliated with an established organization.
5. The camping leader who reserves a campsite must be at least 18 years of age.
6. All juvenile persons of an unorganized juvenile group shall have in their possession a letter of approval from a parent or legal guardian, upon entry into the campground.
7. Applications will be accepted for a minimum of seven (7) nights at Russell Park. Rock Dam Park requires a three (3) night minimum reservation on holiday weekends and two (2) nights minimum for all other times. Mead Lake and Snyder Park accept reservations on holiday weekends only, with a 3 night minimum reservation.
8. The Forest and Parks Department reserves the right to change the assignment of sites as necessary. An extended length of stay on the same site beyond the original reservation period is not guaranteed due to other reservation requests.
