WHERE TO BEGIN?

Many questions can arise when planning the construction of a new house, rebuilding or replacing an existing house or replacing a POWTS (private onsite wastewater treatment system). This brochure was developed to help the landowner understand when and what permits are required in Clark County. The more information the landowner has, the smoother the process should go. Many of the permits can and should be obtained well before any construction begins.

The regulatory framework for a POWTS or non-plumbing sanitation system designed to handle domestic sewage is provided by Wisconsin Administrative Code and Clark County POWTS Ordinance. The Clark County Planning and Zoning Department is the county agency responsible for the regulation and inspection of POWTS and non-plumbing sanitation systems as well as the issuance of sanitary permits. The purpose of the sanitary permit is to allow installation of a POWTS or installation of a non-plumbing sanitation system as described on the approved permit application. The soil and groundwater conditions reported for the property form the basis for a sanitary permit application as do other specifications submitted along with the application.

The type of permit required depends on the type of system the landowner plans to have installed on the property. Installation of a POWTS requires a state sanitary permit. Installation of a non-plumbing sanitation system (privy, composting toilet, etc.) or reconnection to an approved existing POWTS requires a county sanitary permit.

We hope that this brochure will help you understand the process that must be followed in order to install a new or replacement POWTS on your building site or property.

STATE SANITARY PERMITS

Step 1. The Soil Test Report

The first step required to obtain a state sanitary permit is to contact a certified soil tester (CST) to evaluate the soil and site conditions on your property.

A list of CST's that are active in Clark County is included in this brochure. This list does not include all certified CST's. Any individual certified by the state in soil testing is qualified to do the work. Site and soil evaluations can be accomplished by using a backhoe, hand-dug pits or soil auger borings, and surface observations.

Whichever method is used, the CST should do a thorough evaluation of the soils over the ENTIRE acreage of the property. The most suitable soils for use in a POWTS should be identified and recorded for use in the POWTS design. A master plumber or licensed POWTS designer uses the soil report as the basis for their design. After the CST completes the work, you should receive a copy of the soil report form. It is the responsibility of the CST and plumber/designer to explain to you the type of POWTS suitable for your property. The CST also must file the completed soil report form upon completion with the Clark County Planning and Zoning Department.

Step 2. Choosing an Installer

Only licensed plumbers can install POWTS. Before a state sanitary permit can be issued, a Master Plumber or Master Plumber-Restricted Service must assume responsibility for the system installation by signing an application form. A list of licensed plumbers active in Clark County is also included in this brochure. This list does not contain all those qualified to do the work. You may contract with any plumber licensed by the State of Wisconsin as a Master Plumber or Master Plumber-Restricted Service.

CONSUMER QUESTIONS. *The Clark County Planning & Zoning Department recommends obtaining and comparing detailed bids from several plumbers before signing a contract. Submit a copy of your soil report form to various plumbers to obtain these detailed bids. Ask the installer what are you getting for your money? What is included and excluded from the bid? Will the site be landscaped after the job has been completed? Does the bid include removal of excess soil, brush and trees? Does the bid include the construction of required service drive for a holding tank installation?*

CONSUMER COMPLAINTS. *When you are misled or treated unfairly, you have a right to complain. Your complaints make us aware of potential problems. If you have a complaint, please contact the Clark County Planning and Zoning Department. You can also contact the Wisconsin Better Business Bureau at (800) 273-1002.*

Step 3. State Sanitary Permit Issuance

SANITARY PERMIT APPLICATION. The sanitary permit is the regulatory device for assuring compliance with state statutes, the Wisconsin Administrative Plumbing Code, and for granting permission to install a POWTS. An application form is completed by the master plumber and submitted to the Clark County

Planning and Zoning Department along with the POWTS design. When your sanitary permit application has been approved, you will receive a copy of the approved application form from the Planning and Zoning Department. A sanitary permit card will be mailed to the master plumber to post at the site. The sanitary permit card is the official notice that the proposed POWTS design is approved and a building permit can be applied for from the local municipality.

PLAN REVIEW. All POWTS plans require review and approval. Plans can be reviewed and approved by the state or the county. Plan review fees vary depending on the type of private sewage system. Clark County fees are provided on page 3 of this brochure. After the plans are approved, an original, stamped set of plans is returned to the master plumber.

HOLDING TANK MAINTENANCE AND MONITORING AGREEMENT. A holding tank maintenance and monitoring agreement must be signed by the property owner and local unit of government (township) before Clark County will issue a sanitary permit for a holding tank system. The agreement binds the owner and future owners of the property to the terms and conditions listed. If you are required to sign a holding tank agreement, please make sure the full legal description is placed on the document. Refer to your property deed or tax receipt for the proper legal description. Incorrect or incomplete legal descriptions could lead to a delay in processing your sanitary permit application.

SERVICING REQUIREMENTS. POWTS maintenance, management, and reporting are the legal responsibility of the property owner. Service requirements are spelled out in the maintenance and management portion of the POWTS design and also in the user's manual. The POWTS installer is required to provide the property owner with a copy of a user's manual at system start-up. The property owner of a POWTS that requires scheduled maintenance or servicing more than once a year must sign a servicing contract with an appropriate service provider. A holding tank always requires a servicing contract with a licensed pumper. When applicable, a servicing contract must be completed before a state sanitary permit will be issued.

Copies of holding tank maintenance and monitoring agreements and servicing contracts are available at the Clark County Planning & Zoning Department upon request.

Step 4. Installation and Inspection

All POWTS installations require inspection by the Clark County Planning and Zoning Department to verify compliance with the issued sanitary permit. County personnel licensed as a State of Wisconsin POWTS inspector perform system inspections. The inspector's duty is to make sure that the work is completed according to the state plumbing code and conditions of the sanitary permit. Inspections shall be made by the end of the next workday excluding Saturdays, Sundays

and holidays, after the plumber in charge notifies the county.

An inspection report is completed and filed with the sanitary permit. If the system is not installed according to the approved plan, it is noted on the inspection report. A plan revision may be required if changes impact system performance.

A Note on Holding Tanks

An alternative to onsite treatment is the holding tank. While soil-based treatment systems treat and recycle wastewater onsite, a holding tank retains all waste, (including gray water) in a large sealed tank. When the tank is full, these wastes are pumped out by a licensed septage hauler and transported off site for treatment or land spreading. Holding tanks might cost less to install, but annual pumping costs can be substantial.

A holding tank installation requires a service drive less than 25 feet from the tank manhole(s). Holding tanks must remain locked when not being serviced by a licensed septage hauler.

COUNTY SANITARY PERMITS

A county sanitary permit is required when a non-plumbing sanitation system is installed or when a new or rebuilt building is reconnected to an existing POWTS. Non-plumbing sanitation systems include pit and vault privies, composting toilets, incinerating toilets, and chemical toilets. Permits are issued for these systems to ensure that horizontal setbacks from buildings, surface water, property lines, road right-of-ways, and wells are maintained and vertical separation of pit privy waste from groundwater or bedrock is maintained. Reconstructions to existing POWTS are regulated to ensure that the existing system has the capabilities to treat or store the anticipated wastewater flow from the structure.

RECONNECTIONS

Step 1. Existing POWTS Inspection

The first step in obtaining a county sanitary permit for a reconnection is to have the existing POWTS evaluated by a licensed POWTS inspector or plumber. This is required for any reconnection. The system will be evaluated to determine if all the installed components are operating correctly and comply with appropriate plumbing code. The ability of the existing system to treat or store the anticipated volume and strength of the structure's wastewater will be determined. Existing county records can aid in the system evaluation.

Step 2. Application & Site Plan

A licensed master plumber or master plumber – restricted service must sign the county sanitary permit application. The application must include a site plan locating the POWTS, buildings, property lines, well, surface water, driveway and roads. A system evaluation must be provided. Submit the application paperwork and necessary fee to the Clark County Planning &

Zoning Department. A maintenance and management plan and any servicing or maintenance contracts must accompany the application.

Step 3. Installation

A properly licensed master plumber or master plumber – restricted service must perform the reconnection. All reconNECTIONS require inspection by the Clark County Planning and Zoning Department.

NON-PLUMBING SANITATION SYSTEM

Step 1. Is a Soil Test Required?

A soil test is required for installation of a pit privy. Other non-plumbing sanitation systems do not require a soil test.

Step 2. Application & Site Plan

Submit a plot plan showing the location of buildings, roads, surface water, well, property lines, and sanitation system. The county sanitary permit application for a non-plumbing sanitation system does not require the signature of a licensed plumber. A permit fee is required for all non-plumbing sanitation system applications. *

Step 3. Installation

Installation by a plumber is not required. The Clark County Planning and Zoning Department will conduct a post - installation inspection.

UNIFORM ADDRESS SYSTEM.

The Clark County Planning & Zoning Department issues address numbers. For more information or to receive an application call (715) 743-5130.

RURAL HOUSING PROGRAMS.

The Clark County Housing Authority administers state and federal government housing programs to low and moderate income homeowners in Clark County. This includes zero percent interest, deferred payment loans made possible through a Community Development Block Grant program for wells, POWTS, and other home improvements. For more information contact the Housing Authority office at (715) 255-9396.

UNIFORM DWELLING CODE (UDC).

Effective January 1, 2005, all new construction of buildings intended for human habitation must be inspected for compliance with standards provided in the Wisconsin Uniform Dwelling Code. Clark County does not provide these inspection services. The inspection services are provided by private individuals or companies licensed by the Department of Commerce. Please contact the local municipality in which you will be building for further information.

LOCAL BUILDING PERMIT

In addition to the UDC permit, some municipalities may still require that a local permit be issued. A SANITARY PERMIT IS REQUIRED BEFORE THE MUNICIPALITY CAN ISSUE A BUILDING PERMIT. A building permit is your legal permission to begin construction. For more information about your municipality’s building permit program, contact your Town Chairperson.

WISCONSIN FUND GRANT PROGRAM

This program provides reimbursements to aid in the replacement failing POWTS. To apply for a grant you must obtain a sanitary permit, complete an application, and provide evidence of your annual income. Some restrictions do apply. Contact the Clark County Planning & Zoning Department to obtain a brochure and application form.
